PROGRAM: **Workers' Compensation** losses are pooled by CALIFORNIA JPIA Members to \$2 million. Coverage* from \$2 million to \$300 million is purchased. Any loss in excess of the purchased limit will be pooled by CALIFORNIA JPIA Members.

Employer's Liability losses are pooled by CALIFORNIA JPIA Members to \$2 million. Coverage** from \$2 million to \$5 million is purchased. Any loss from \$5 million to \$10 million will be pooled by CALIFORNIA JPIA Members.

PROTECTION PERIOD: July 1, 2007 to July 1, 2008 at 12:01 a.m. Pacific Time

PROTECTS: CALIFORNIA JPIA Members (and their employees, including the Member's city council, board of directors, or other legally authorized or appointed committees or commissions of the Member) that have entered the Workers' Compensation Program by resolution of the agency's legislative body.

COVERS:

1. Statutory liability under California Workers' Compensation Law, and
2. Employer's Liability.

LIMITS: Under (1) Scheduled Statutory Benefits
Under (2) \$10,000,000 per Occurrence

COVERAGE NOTE: Volunteers covered only if Workers' Compensation coverage has been extended to them by resolution of the agency's legislative body.

*Excess coverage is provided by California State Association of Counties – Excess Insurance Authority (CSAC-EIA). Losses from \$2 million to \$5 million are pooled with CSAC-EIA members. Reinsurance is purchased from \$5 million to \$50 million from CSAC-EIA, which purchases excess insurance from Renaissance Reinsurance Limited (Renaissance Reinsurance Limited excludes Terrorism coverage, therefore CSAC-EIA purchases this coverage from Axis Specialty Limited, Lancashire Insurance Company Limited and Lloyd's of London). Reinsurance is purchased from \$50 million to \$300 million from National Union Fire Insurance Co. of Pittsburg, PA with no Terrorism exclusion. Some exclusions and sub-limits apply, see policy summary for more information.
